

# Export Scheme Advisory

SunStar Marine team has a vast knowledge, experience and expertise in the field of Foreign Trade Policy. We help our clients for facilitation of various licenses from DGFT (Directorate General of Foreign Trade). We provide support to clients in preparing applications, documentation of import – export statements and monitoring exports against licenses taken from DGFT.

#### MEIS (Merchandise Export from India Scheme)

MEIS is an Incentive Scheme introduced in the Foreign Trade Policy of India (2015-2020). Incentive schemes can entitle the exporters to duty credit scrips subject to various conditions and gives a value of 02-05% on FOB from export of goods from India in the form of duty credit script.



SEIS is an Incentive Scheme introduced in the Foreign Trade Policy (FTP) of India (2015-2020). The main objective of SEIS is to encourage export of notified services from India. A service provider located in India, providing notified services rendered in the specified manner shall be eligible for reward at the notified rates on the net foreign exchange earned.

#### MEIS/ SEIS License Purchase and Sale

These licenses are purchased directly from Exporter's who are not importing any goods and wish to sell their scrips. We act as a broker in between Exporter & Importer for sales of MEIS/SEIS License as per current market price. We are one of the leading broker in MEIS/SEIS license trade and the trade is governed as per Foreign Trade Policy.





#### EPCG (Export Promotion Capital Goods)

EPCG Scheme allows import of capital goods for pre-production, production and post-production at Zero customs duty. We can assist client's in assessing the feasibility of the scheme for exports/domestic supplies, planning for maximum benefits, documentation, application preparations, representation and coordination with DGFT and other concerned Government Departments till the client's finally gets the authorisation. Later on, we will assist in redemptions of the authorisation.
